# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.603AutoSalvage.com, and 603 Auto Salvage and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to 603 Auto Salvage include www.603AutoSalvage.com and 603AS. The 603AS website is a Ecommerce site. By using the 603AS website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, 603AS may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## Use of your Personal Information

Tracking User Behavior
